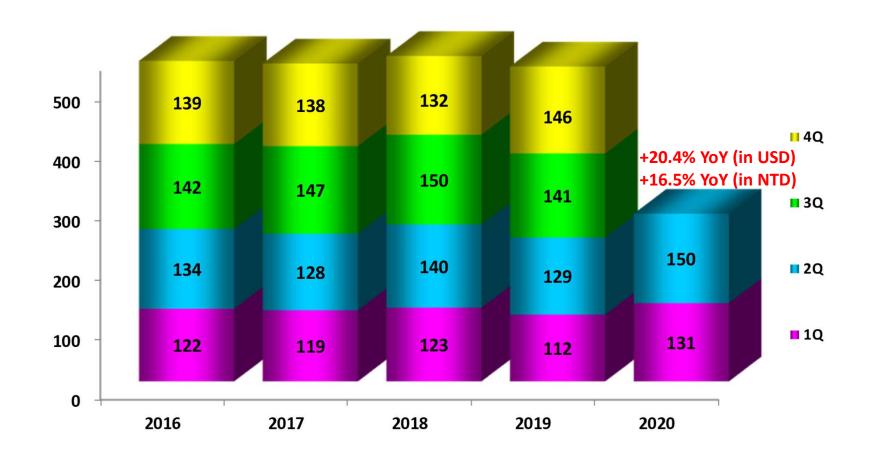

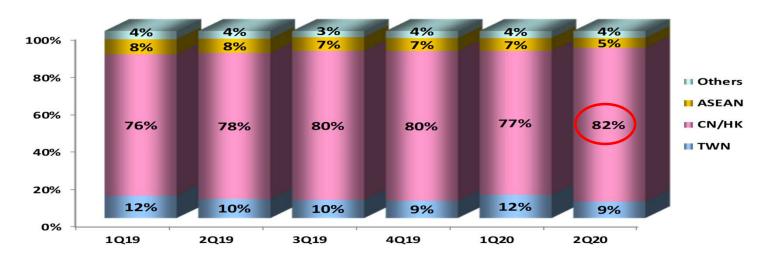

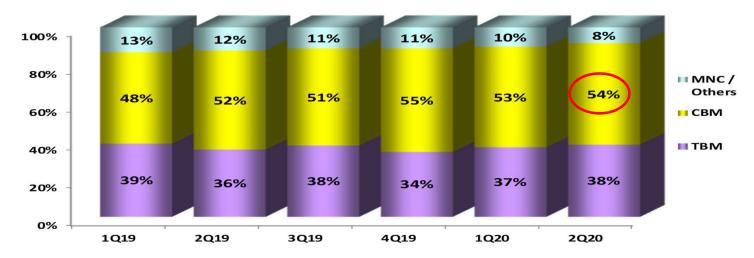

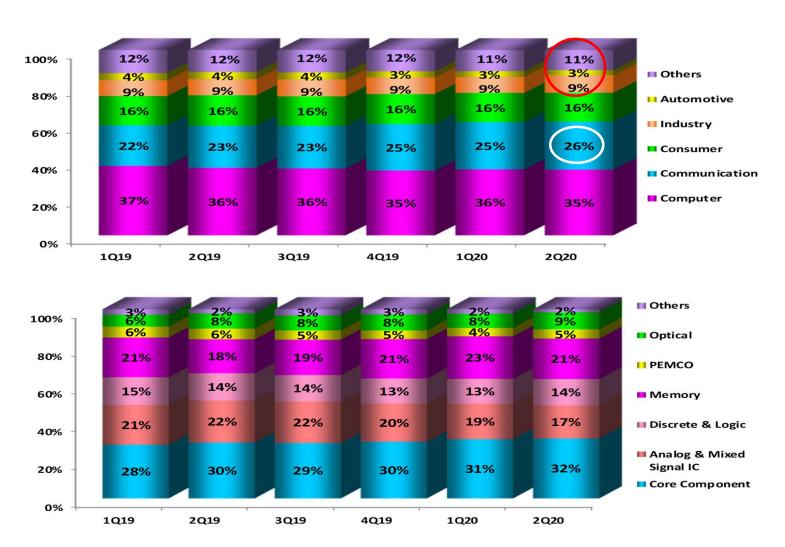
Sales breakdown by Geography/ Customerupg





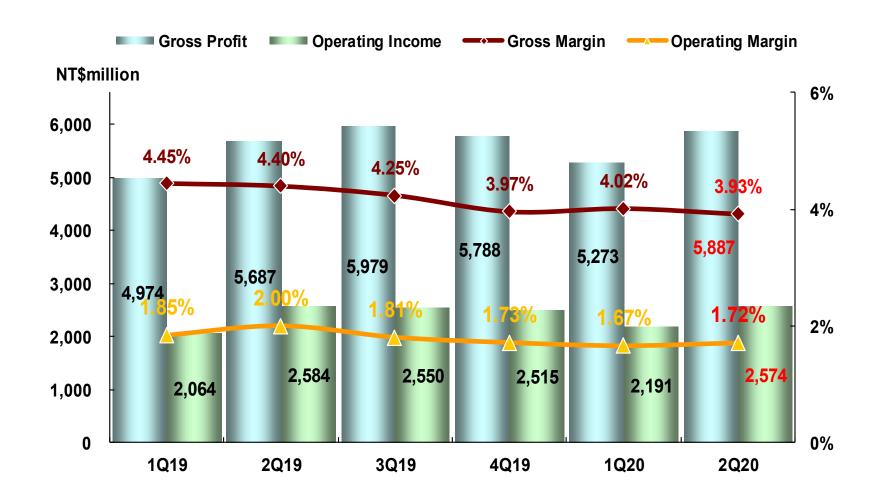

Sales breakdown by Application/ Device Typerg



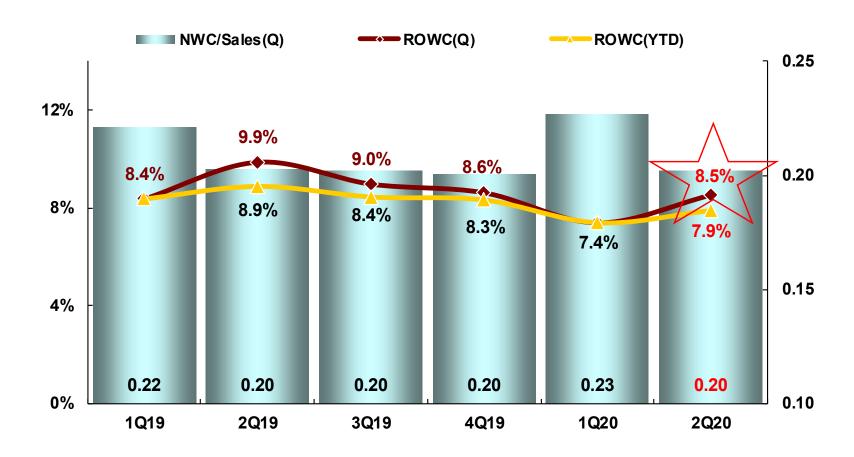
Gross Margin vs. Operating Margin





ROWC vs. NWC/Sales

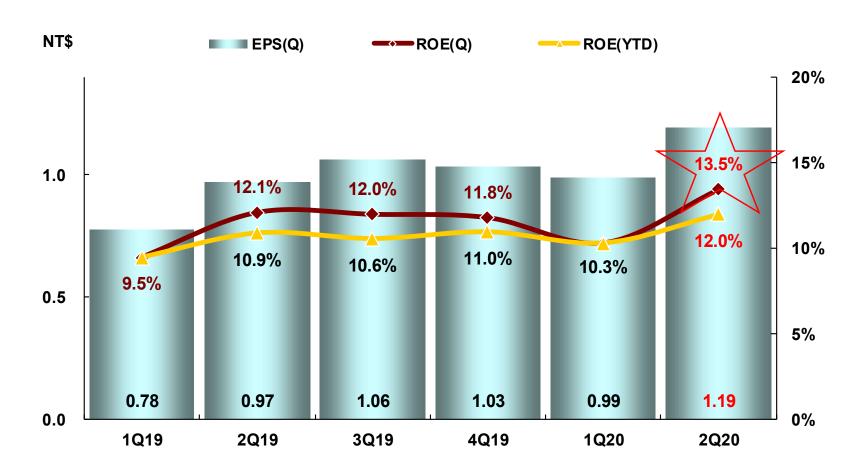

ROE vs. EPS

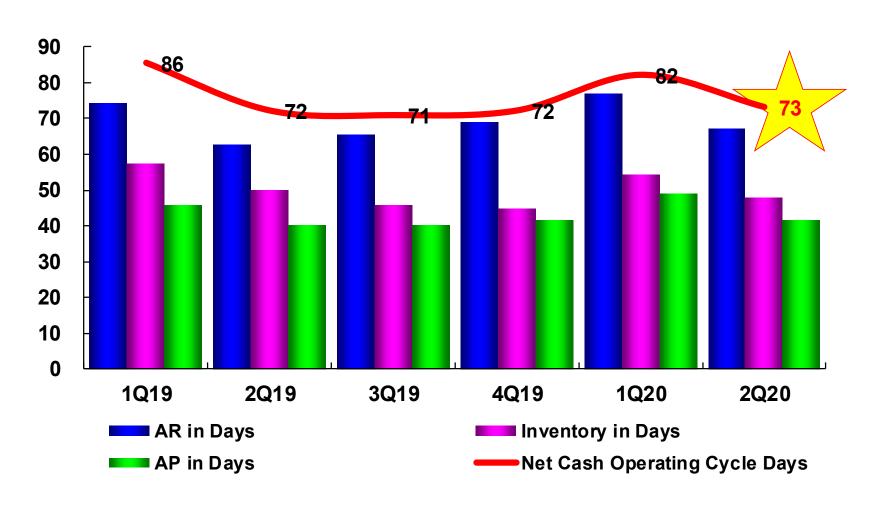

Operating Cash Cycle

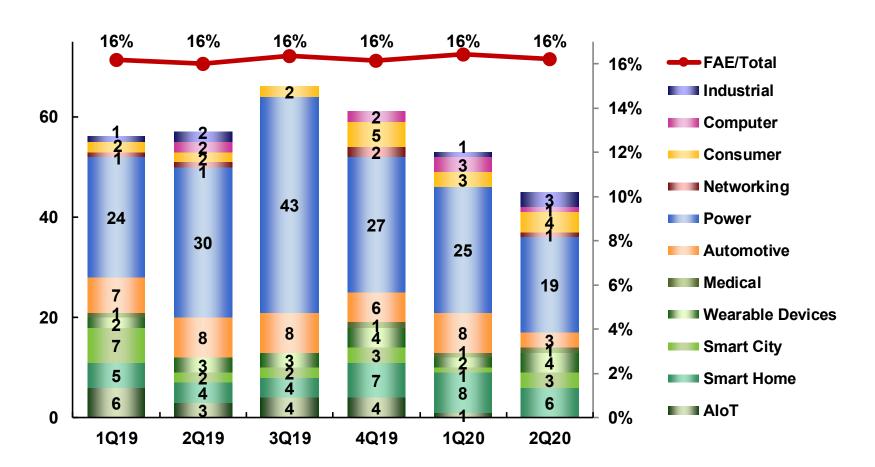

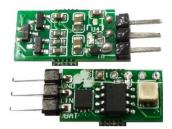
